

COVID-19 Compliance Questions Before CCC Events

NO answers required for compliance for questions 1 – 4.

1. Have you **been diagnosed** with COVID-19?
2. If you are not a front-line worker, have you **been exposed** to a person with a confirmed or suspected case of COVID-19 in the last 14 days?
3. Have you **experienced**, or anyone in your household experienced, any signs or symptoms of COVID-19 in the last 14 days (including fever, new or worsening cough, fatigue, chills and body aches, respiratory illness, difficulty breathing, nausea, vomiting or diarrhea, or loss of taste or smell)?
4. Have you or any members of your household **travelled** to or had a lay-over in any country outside Canada in the past 14 days?

YES answers required for compliance for questions 5 – 11.

5. If you have been diagnosed with COVID-19, have you been **cleared as non-contagious** by provincial or local public health authorities?
6. If you are a front-line worker, have you **worn proper and approved Personal Protective Equipment** at all times whenever you interacted with an individual who has a confirmed or suspected case of COVID-19 in the last 14 days.
7. Do you understand the risks associated with COVID-19 and **agree to assume those risks**, including but not limited to exposure and being infected?
8. Should you experience, or anyone in your household experience, any signs or symptoms of COVID-19 after signing this **Declaration of Compliance**, do you **agree to immediately isolate**, notify the CCC, and not attend any of the CCC's events until at least 14 days have passed since those symptoms were last experienced.
9. If you or anyone in your household should travel outside Canada after signing this **Declaration of Compliance**, do you agree that you **will NOT attend** any of the CCC's events, until at least 14 days have passed since the date of return.
10. Do you **agree to follow recommended guidelines**, including but not limited to, practicing physical distancing, trying to maintain separation of six feet from others, adhering to recognized hygiene best practices, and otherwise limiting exposure to COVID-19?
11. Do you **agree to follow the safety, physical distancing and hygiene protocols of the CCC**?
